# December 19, 2017 Town of Lyme

Public Hearing – Zoning Law Revisions – 6:15 P.M.

Supervisor Aubertine called the Public Hearing to consider the Zoning Law Revisions to order at 6:15 p.m.

The public hearing notice appeared in the Watertown Daily Times on December 6, 2017 as follows:

The Town Board of the Town of Lyme is rescheduling the Regular Monthly Meeting that was scheduled for December 13, 2017 at 6:30 p.m. to Tuesday December 19, 2017. Public Hearing are scheduled to begin at 6:15 p.m. to consider revisions to the Town's Zoning Law and 6:25 p.m. to adopt the 2018 Water Rates. The Regular Monthly Meeting will commence at 6:30 p.m. or immediately following the Public Hearings. The meeting will be held at 12175 NYS Route 12E, Chaumont, NY 13622. By Order of the Town Board, Town of Lyme.

The Town Board is considering the process of the special review for the Planned Development Districts to be given to the Town Planning Board and it would no longer be the responsibility of the Town Zoning Board of Appeals. The only change in the Zoning Law would be the wording; it would read Town Planning Board where it now reads Zoning Board of Appeals.

Needs to discuss the possible submission of one or more Community
Disaster Block Grants (CDBG) applications for the 2017 program year. The
CDBG Program is administered by the New York state Office of
Community Renewal (OCR) and will make available to eligible local
governments approximately \$10,000,000.00 (ten million dollars) for the
2017 program year for housing, economic development, public facilities,
public infrastructure and planning activities, with the principal purpose of
benefitting low/moderate income persons. The Hearing will provide
further information about the CDBG Program and will allow for citizen
participation in the development of any proposed grant applications
and/or provide technical assistance to develop alternate proposals.
Comments on the CDBG Program or proposed projects will be received at
this time. The Public Hearing is being conducted pursuant to /section
570.486, Subpart I of the CFR and in compliance with the requirements of
the Housing and Community Development Act of 1974 as amended.

<u>RESOLUTION 2017 – 154</u>: Motion by Councilwoman Harris and seconded by Councilman Villa approving the Model Resolution for Residents Opposing Wind Farm Development in Proximity to Fort Drum:

WHEREAS, protecting the North Country's airspace is vital to Fort Drums future as the Army is continually evaluating the effectiveness of its training installations and;

WHEREAS, wind farm development can be an important initiative to pursue as it offers a green source of energy that is pollution free and generated at the source, and while we recognize the benefits of wind farm development we simply do not want the strategic location of Fort Drum and their mission readiness capability to be diminished; and

WHEREAS, as the major economic engine of the North Country and the largest single employer, the economic vitality of the region and thousands of jobs depend on its continued relevance to the Army mission; and

WHEREAS, protecting and enhancing Fort Drum, home to the Tenth Mountain Division, is of utmost priority to the Town of Lyme.

NOW THEREFORE BE IT RESOLVED that the Town Board of the Town of Lyme opposes the industrial wind projects being evaluated by New York State's Article 10 Siting Board and the Public Service Commission in the immediate proximity to Fort Drum to ensure the national security and continued readiness for future training missions.
