Assessor's Report - No Report This Month

Municipal Water Board Report:

Old Town Springs Road - Water District #5 - A letter was sent to all residents of the District informing them that Bernier and Carr were completing studies. The letter gave them the opportunity to let the Water Board know if they did not want someone on their property. They were also given an update on the status of the District.

Point Salubrious Water Project Study - Nothing new to report at this time.

New York State DEC Request – Mike Contino – Real Property Supervisor for the DEC requested that their newly acquired property in Three Mile Bay be granted exempt from water billing. He said New York State would not pay water bills. The property originally had 2 hook-ups or full EDU's. One meter was removed and the other was left, as it is in the asphalt. The Water Board reduced the EDU count from 2 to ¼ and ½. The situation was discussed with Mr. Contino's Supervisor and they would pay what they currently owe, minus the penalties and then they would like to be removed from the water billing. Marsha told Mr. Contino that she would have to be directed by the Town Board to cease the billing.

USDA Request - A letter was received from the USDA, which states, as a condition of our loan, a proposed budget for the fiscal year ending December 31, 2009 must be submitted by December 1, 2008. A copy of the Town's adopted budget will be sufficient, with the summary sheet they enclosed. Sovie and Bowie should be preparing the paperwork.

DANC's Annual Certification – Bryon Perry from DANC has requested the number of EDU / Hookups. A letter has been returned to him, informing him that there are 185 total for the Town. The numbers are as follows:

Three Mile Bay Cemetery Report - Terra's work in the cemetery is almost complete. She has a little weed eating to do and will then turn in her final voucher. The excessive rain has made it an unusually difficult year.

Julie has had several phone calls concerning information about lot prices and interments.

Julie is back in winter mode, doing research to determine the current legal owners of all the older lots. This is a big job but is going very well.

Planning Board - Boo - The Town of Lyme Planning Board proposes updating our current 1999 Comprehensive Plan. Due to changes in our community, the environment and both recent and prospective growth, the Planning Board feels the time is past due to revise the plan for the future. They will use various methods, including a mail survey followed by public meetings to identify needs and get citizen input. The Planning Board will also receive assistance in conducting and evaluating the survey, as well as other data from the County Planning Board staff. They also plan to obtain information from the NYS Planning Federation.

Because any plan for the Town of Lyme must recognize and include plans affecting the Village of Chaumont, the Planning Board has been working together with the Village Planning Board to develop the survey. They will

have a draft survey available soon and plan to test it by asking Town and Village officials to fill out the survey questions too determine if it is clear enough before it is disseminated to the general public.

Youth Committee Report - Charlie Mount - The winter basketball program is waiting for approval from the school. There has been a change of leadership and policy at the school.

The Committee has reviewed the applicants for the Teen Center Director and would like to recommend to the Town Board, Mike Nichols is appointed as soon as possible as to get the Youth Program underway.

ZEO no report

ZBA - Ernie Brister - The ZBA held its monthly meeting on November 5th, there were no hearings or variances granted. After the meeting they held a work session with Anthony Leone, the new owner of the Creek Side property in Three Mile Bay, to help him fill out a Special Permit for a business on this property, at his request. Between the ZBA and ZEO most questions were answered. Mr. Leone is to complete the Permit and submit it to the ZEO.

Police Report - Written Report Submitted for October 2008. Leo would like to have the ability to relocate the new speed trailer. Pat Weston will take a look to see if he can get Leo's vehicle set up so he'll be able to move the speed trailer himself.

Salt - Norm - IMUS cannot supply the Town salt at this time. Councilman Schreib did get a hold of the Morton Salt Company. They will be giving us a quote. The company does have a large supply in Ogdensburg. The price is approximately \$65.00 per ton, pick up price.

Dick Nage! - Transfer Site was open on Veterans Day, the employees were not notified to close. The rest of the Town took a holiday while that part of the work force was still working.
