Town of Lyme May 9, 2018 Regular Monthly Meeting of the Town Board 6:30 P.M.

Supervisor Aubertine opened tonight's meeting with a Prayer and the Pledge of Allegiance at 6:30 p.m.

Present at tonight's Meeting: Supervisor Aubertine, Councilwoman Gosier, Councilmen Bourquin, Villa and Jones, Assessor Chairwoman Marsha Barton, ZEO/CEO Millington, Jefferson County Legislator Bill Johnson and approximately six others.

Privilege of the Floor

Elizabeth Martin – Grant Options

Elizabeth presented the Town Board with possible grant and purchase options for the Magee property.

Supervisor Aubertine had concerns with getting the information to the Town residents; "if they are going to vote on this they need to be educated". He has issues that if we are not able to obtain grant money for the project the Town will be able to do very little with the property. There is a six year conceptual plan that will cost approximately 1.2 million dollars to bring the project to completion. The Town Board has to decide what they want to do with the property.

Councilman Villa feels the Town should purchase the property first and after the purchase let the residents weigh in on what to use it for, he would like to move forward with buying the land.

Councilman Bourquin would like to wait to commit to the purchase until we can show the voters the potential of the project.

Elizabeth recommends the CFA Grant and she would be willing to write it. Her rate will be twenty-five dollars per hour. Up to this point Elizabeth has less than

15 hours into the paperwork. Supervisor Aubertine would like to turn everything over to Elizabeth and have her do everything. The Town Board will amend her agreement at the June meeting.

Matt Biondolillo suggested there could be other opportunities available the Town should not lose focus on other properties. He would like to share more information on other opportunities and a variety of strategies.

<u>RESOLUTION 2018 – 57</u>: Motion by Councilman Villa and seconded by Councilwoman Gosier accepting the purchase offer on the Magee Property in the amount of \$480,000.00 (four hundred eighty thousand dollars) with the Towns sharing being \$330,000.00 (three hundred thirty thousand dollars) and the Williams/Schweitzer share to be\$150,000.00 (one hundred fifty thousand dollars). The purchase of the property will be bases on Public Referendum. Five ayes. Motion carried.

<u>RESOLUTION 2018 – 58</u>: Motion by Supervisor Aubertine and seconded by Councilman Villa authorizing the publication of notice for authorizing issue of a Cerial Bond with the Town Share not to exceed \$336,000.00 (three hundred thirty-six thousand dollars).

Attorney Gebo will take care of details on the elections.

Mike Lasell - Cohen Campground

Asking for permission to add four more sites to the existing RV Park. The Town Board has had ongoing problems with the Cohens and will not move forward until all requirements are met.

Councilman Villa stated the Town was in favor of the project going forward. The Cohens moved forward doing whatever they wanted to and it has been inappropriate. They come to the Town and ask for forgiveness after the fact.

Cohen has built without the proper permits and the Town is upset.

Mr. Lasell stated that he would provide the Town with a true plan as to what the Cohens would like to see for the path forward.

Three Mile Bay Sewage System – Gregor Smith contacted Marsha regarding rebidding the project for the Three Mile Bay Sewer System. There may be additional funding that could make the project more affordable. Supervisor Aubertine stated we will rebid as long as there are no additional costs to the Town.

Survey – 61 surveys were sent to residents residing on 12E from Chaumont to Three Mile Bay and the Swamp Road to the Town Line. They have received 17 back, several people have shown an interest.
